

Privacy Policy Effective as of July 27, 2020

Protecting your private information is our priority. This Statement of Privacy applies to www.talentuplifted.com and Talent Uplifted LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Talent Uplifted LLC include www.talentuplifted.com and Talent Uplifted. The Talent Uplifted website is a blog, offers programs and services, and additional e-commerce. By using the Talent Uplifted website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Talent Uplifted may collect personally identifiable information, such as your:

- First and Last Name
- E-mail address
- Phone number

If you purchase Talent Uplifted's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Talent Uplifted's public message boards, this information may be collected and used by others.

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that
 adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to
 render impossible or seriously impair the achievements of such research, provided we have obtained
 your informed consent;

- Comply with an existing legal obligation; or
